Later on 13<sup>th</sup> June 2008 the First Amendment to the Trust Deed was registered in the office of the Sub Registrar Office as No. 184 of 2008 of Book IV, Volume 167, on Pages 23 to 26.

As per the Provision 28 of the Trust Deed, "the trustees may by 2/3<sup>rd</sup> majority amend, delete or modify the existing provisions of the trust deed."


The Trust board meeting held on 8<sup>th</sup> Dec 2017 at Samskruthi School Panthavoor, took the following decisions. Among other clauses in the last amended deed executed on 13<sup>th</sup> June 2008 the following clauses may be added which will form part and parcel of the original trust deed.

- a) The board meeting unanimously agreed to change the provision 18, to the effect that total strength of the board shall not exceed 21 (formally it was 15)
- b) No objects /clauses in the deed approved by the Commissioner of Income Tax shall be changed or amended without the prior permission of The Commissioner of Income Tax.
- c) The benefits/services of the trust are open to all, irrespective of cast, creed, religion, sex etc.
- d) In the event of winding up of the trust, the trust properties shall be transferred to another trust having the similar objectives and in case no such trust is found or not willing, the whole of the trust properties will be transferred to the Government.
- e) The trust constituted shall be irrevocable.
- f) The trust funds shall be invested strictly in accordance with the provisions of the section 11(5) read with section 13(1) (d) of the Income Tax Act .
- g) The objects of the Trust shall be carried out only in India.

- h) The Income and funds of the trust will solely be utilized for the objects and no portion of it will be utilized for the payments to the trustees, members and office bearers by way of profit/dividend/interest etc.
  - i) In case the trust intends to run any business, it will satisfy the conditions stipulated in section 11(4) and proviso to section 80G(5) (1) of the Income Tax Act
  - j) The accounts of the trust shall be regularly maintained and every year the accounts shall be closed by 31st March and the same shall be audited by a qualified Chartered Accountant and file an audited financial statements and auditors report before the Income Tax Department on or before the due date.
  - k) The amendments of the Trust shall be registered in the Sub Registrar Office, Edapal, Malappuram Dt and the **Trustee No(2) Sri. Pramod T**, (Aadhaar No 3629 5365 1686) aged 51 years, Teacher, S/o (Late) Sri. Narayanan Nair T, now residing at "Sukruthi" Panthavoor, Post Alankode, Malappuram Dt, Kerala State shall represent and execute it.
  - l) The Capital amount of the trust remain the same Rs.10000/- (Rupees ten thousand only) as per the provision 27 of the registered deed as constituted by the constituents viz Donor's nos1 &2 and stamp duty is paid accordingly.
